RESOLUTION NO. SP- **8217**, S-2020

A RESOLUTION RECOGNIZING THE OFFICIAL LIST OF IDENTIFIED HERITAGE AND CULTURAL SITES IN QUEZON CITY, AS PREPARED AND CERTIFIED BY THE QUEZON CITY TOURISM DEPARTMENT.

*Introduced by Councilors EDEN DELILAH "Candy" A. MEDINA
and DIORELLA MARIA G. SOTTO-ANTONIO.*

WHEREAS, Section 15, Article XIV of the 1987 Philippine Constitution provides that "The State shall conserve, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations";

WHEREAS, one of the policies of the State is to preserve and protect important cultural properties and national cultural treasures of the nation and safeguard their intrinsic value;

WHEREAS, the country's artistic and historic wealth constitutes as cultural treasure of the nation and shall be under the protection of the State;

WHEREAS, under Republic Act No. 10066, otherwise known as the "The National Cultural Heritage Act of 2009", the local government units, through their cultural offices, shall maintain an inventory of cultural properties under its jurisdiction and shall furnish the National Commission for Culture and the Arts (NCCA) a copy of the same;

WHEREAS, Section 7 of the Implementing Rules and Regulations (IRR) of Republic Act No. 10066 states that "The Cultural Property of the country, whether public or privately owned, movable or immovable, and tangible or intangible shall be categorized as follows:

The following shall be declared as Grade I level:

- a) World Heritage Sites;*
 - b) National Cultural Treasures;*
 - c) National Historical Landmarks;*
 - d) National Historical Shrines; and*
 - e) National Historical Monuments*

The following shall be declared as Grade II level:

a) *Important Cultural Properties*

WHEREAS, Section 8 of the same IRR provides that all Cultural Properties are considered important Cultural Property such as;

- a. Works by Manlilikha ng Bayan;
- b. Works by National Artist;
- c. Archeological, traditional, ethnographic material;
- d. Works and Structures at least 50 years old;
- e. Archival materials or documents at least 50 years old;
- f. Rarebooks and Incunabula declared by the National Library of the Philippines.

WHEREAS, the Department of the Interior and Local Government (DILG) and the NCCA issued Joint Memorandum Circular No. 2018-01, otherwise known as the "Local Inventory of Cultural Property as required under Republic Act No. 10066", enjoining the local chief executives to maintain a local inventory of all cultural property within their jurisdiction;

WHEREAS, The NCCA issued Board Resolution No. 2017-330, entitled "Guidelines Governing the Philippine Registry of Cultural Property (PRECUP)" requiring the local cultural database to be accompanied with a Sanggunian resolution or ordinance recognizing it as the local inventory.

WHEREAS, the Quezon City Tourism Department, as of April 2019, created and prepared a list of identified heritage, sites, landmarks, monuments and cultural resources and properties within the jurisdiction of Quezon City. The list of the said heritage and cultural sites identified by the Tourism Department of Quezon City are as follows:
