RESOLUTION NO. SP- **8242**, S-2020

A RESOLUTION URGING THE DISTRICT DIRECTOR OF THE QUEZON CITY POLICE DISTRICT (QCPD) TO DIRECT THE DEPLOYMENT OF ADEQUATE NUMBER OF MOTORCYCLE POLICEMEN IN MAJOR THOROUGHFARES, BUSINESS CENTERS, SCHOOL ZONES, AND OTHER CROWDED AREAS OF QUEZON CITY TO ENSURE QUICK RESPONSE EVERY TIME THERE IS AN OCCURRENCE OF CRIMINALITY INVOLVING RIDING-IN-TANDEM.

WHEREAS, criminalities in major thoroughfares, business centers, school zones, and other crowded areas, particularly those involving motorcycle riding-in-tandem, are beginning to strike, not only in Quezon City but also in other parts of Metro Manila, and one incident of which was the straffing of the service vehicle of popular actress Kim Chiu;

WHEREAS, considering that these criminals are using motorcycles to easily run after their targets or potential victims and to quickly get away, there is a need for an adequate number of motorcycle policemen who can accost, chase, and apprehend them despite the hindrance of vehicular traffic;

WHEREAS, the presence of motorcycle policemen in major thoroughfares, business centers, school zones, and other crowded areas will also serve as a deterrent for the possible commission of other crimes;


WHEREAS, public safety and security is one of the vital components of economic progress and have a potentially dramatic impact on public order that must be given utmost priority.


RESOLVED FURTHER, that a copy of this Resolution be forwarded to the Office of the District Director of QCPD, for their information and appropriate action.


