RESOLUTION NO. SP- 8249, S-2020

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE TO ACCEPT THE DONATION OF PHILIPPINE CHAMBER OF COMMERCE AND INDUSTRY-QUEZON CITY (PCCI-QC) IN THE AMOUNT OF EIGHTEEN MILLION PESOS (PHP18,000,000.00) FOR THE PURCHASE OF SIX (6) TESTING BOOTHS, WASHABLE AND REUSABLE FACE MASKS FOR CHILDREN AND FOR OPERATIONAL EXPENSES OF THE HOSPITAL ON WHEELS FOR A PERIOD OF THREE (3) MONTHS, FOR THE BENEFIT OF THE RESIDENTS OF QUEZON CITY.

WHEREAS, on March 8, 2020, President Rodrigo Duterte issued Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines to facilitate measures to address the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, on March 13, 2020, the Quezon City Council in a special session adopted Resolution No. 8141, S-2020, which declared Quezon City under a State of Calamity due to COVID-19;

WHEREAS, on April 27, 2020, the Quezon City Council adopted Resolution No. SP-8170, S-2020, authorizing the City Mayor, Honorable Ma. Josefina G. Belmonte to accept the donation of the Philippine Chamber of Commerce and Industry - Quezon City (PCCI-QC) in the amount of Fifty Million Pesos (Php50,000,000.00) for the purchase and distribution of personal protective equipment (PPE) for medical frontliners, testing kits, and other medical supplies and equipment to suppress the Coronavirus Disease 2019 (COVID-19) pandemic in Quezon City;

WHEREAS, PCCI-QC is again intending to donate in favor of the Quezon City Government an amount of Eighteen Million Pesos (Php18,000,000.00) pursuant to its duly adopted Board Resolution No. 007-2020 dated July 6, 2020;

WHEREAS, as per Board Resolution No. 007-2020, the donated amount of Php18,000,000.00 shall be utilized for the purchase of six (6) testing booths, washable and reusable face masks for children and for operational expenses of the Hospital on Wheels for a period of three (3) months, for the benefit of the residents of Quezon City;

WHEREAS, the generosity of the officers and members of PCCI-QC during this time of COVID-19 pandemic is greatly appreciated by the Quezon City Government;

WHEREAS, pursuant to Sections 22 (c) and 455 (b)(1)(vi) of the Local Government Code of 1991, prior authorization by the Sanggunian Panlungsod is necessary.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to accept the donation of Philippine Chamber of Commerce and Industry-Quezon City (PCCI-QC) in the amount of Eighteen Million Pesos (Php18,000,000.00) for the purchase of six (6) testing booths, washable and reusable face masks for children and for operational expenses of the Hospital on Wheels for a period of three (3) months, for the benefit of the residents of Quezon City.

RESOLVED FURTHER, that a copy of the subject Deed of Donation shall form as integral part of this Resolution.
