RESOLUTION NO. SP- 8250, S-2020

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACCEPT THE DONATION FROM MANILA ELECTRIC COMPANY (MERALCO), REPRESENTED BY ITS FIRST VICE PRESIDENT AND HEAD OF CUSTOMER RETAIL SERVICES AND CORPORATE COMMUNICATIONS, VICTOR S. GENUINO, AND VICE PRESIDENT AND HEAD OF NORTH BUSINESS AREA, CHARINA P. PADUA, AND TO EXECUTE THE RELATED DEED OF DONATION AND ACCEPTANCE OF THREE (3) E-TRIKE CHARGING STATIONS FOR INSTALLATION WITHIN QUEZON CITY, WITH THE OBJECTIVE OF PROMOTING ENERGY EFFICIENCY AND CLEAN TECHNOLOGIES IN THE TRANSPORT SECTOR.

WHEREAS, the Quezon City Government received Three Hundred (300) electronic tricycles (E-trikes) from the Department of Energy (DOE) as part of the latter's program to promote energy efficiency and clean technologies in the transport sector;

WHEREAS, the City Government intends to distribute the E-trikes to various beneficiaries consisting of Barangays and Tricycle Operators and Drivers Association (TODA) to supplement the shortage of tricycles plying in certain routes of the City and to eventually replace tricycles with E-trikes;

WHEREAS, to jump-start this program in the City, the beneficiaries need charging stations in order to continually, effectively, and efficiently use the E-trikes;

WHEREAS, Manila Electric Company (MERALCO) is engaged in the business of supply, operation, and management of electric vehicles, and desires to contribute in the promotion of energy efficiency in the Philippines;

WHEREAS, to support the above program of the City Government, MERALCO has offered to donate and install three (3) charging stations to help the City Government in promoting energy efficiency and clean technologies in the transport sector;

WHEREAS, pursuant to Sections 22(c) and 455 (b)(1)(vi) of the Local Government Code of 1991, prior authorization by the Sangguniang Panlungsod is necessary.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Ma. Josefina G. Belmonte, to accept the donation from Manila Electric Company (MERALCO), represented by its First Vice President and Head of Customer Retail Services and Corporate Communications, Victor S. Genuino, and Vice President and Head of North Business Area, Charina P. Padua, and to execute the related Deed of Donation and Acceptance of three (3) e-trike charging stations for installation within Quezon City, with the objective of promoting energy efficiency and clean technologies in the transport sector.

RESOLVED FURTHER, that the subject Deed of Donation and Acceptance shall form an integral part of this Resolution.
