A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO AEKO GASOLINE STATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE/DIESEL DISPENSING SERVICE STATION WHICH SHALL BE LOCATED AT NO. 556 QUIRINO HIGHWAY, BARANGAY TALIPAPA, QUEZON CITY.

WHEREAS, AEKO Gasoline Station, a business entity duly registered under Philippine Laws is applying for a Special Use Permit (SUP) for the construction and operation of a Gasoline/Diesel Dispensing Service Station which shall be located at No. 556 Quirino Highway, Barangay Talipapa, Quezon City;

WHEREAS, under Section 52 (1) of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, a Special Use Permit is required for the construction and operation of a gasoline refilling station, subject to the authorization by the City Council through a Resolution;

WHEREAS, the members of the Sangguniang Barangay concerned and the residents nearby the place of business did not interpose any objection to the construction and operation of the said business establishment;




NOW, THEREFORE,


