RESOLUTION NO. SP- **8295** S-2020

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ONE HUNDRED SIXTY-SIX (166) QUALIFIED SMALL BUSINESSES FOR THE PROVISION OF A STIMULUS PACKAGE INTENDED TO ENSURE THE CONTINUOUS EMPLOYMENT AND BUSINESS CONTINUITY OF ENTERPRISES GREATLY AFFECTED BY THE COVID-19 PANDEMIC.

WHEREAS, on 8 March 2020 President Rodrigo Roa Duterte issued Proclamation No. 922 "Declaring a State of Public Health Emergency throughout the Philippines" because of the COVID-19 pandemic;

WHEREAS, in a Special Session held on March 13, 2020, the 21st City Council adopted Resolution No. SP-8141, S-2020, which declared Quezon City under a State of Calamity due to the pandemic;

WHEREAS, on 16 March 2020, President Rodrigo Roa Duterte issued Presidential Proclamation No. 929 placing the entire island of Luzon under Enhanced Community Quarantine (ECQ) resulting to the closure of all non-essential businesses, suspended mass transportation and prohibited mass gatherings;

WHEREAS, the pandemic and corresponding quarantine efforts have disrupted the economy, and according to the Department of Labor, may displace up to 10 million workers by the end of the year;

WHEREAS, the Department of Trade and Industry has determined that as of July 2020, 25.9% of the businesses in the Philippines has closed since the COVID-19 pandemic hit the country;

WHEREAS, on 29 June 2020, the 21st City Council adopted Resolution No. SP-8208 entitled: "Resolution Approving the Quezon City COVID-19 Pandemic Economic Recovery Plan" that details the economic plans of the Quezon City Local Government Unit (QC LGU) to recover from the pandemic;

WHEREAS, the Quezon City Recovery Plan provides for a stimulus package called "Kalingang QC sa Negosyo", a Wage Relief Program intended for qualified small businesses to ensure continuous employment of its employees and business continuity which could create a multiplier effect in terms of money inflow to the QC LGU economy;

WHEREAS, independent businesses with an asset of more than 3 million up to 15 million pesos, with at least 10 employees, and no pending case before the Quezon City BPLD, DOLE, and BIR were invited to apply for the stimulus package;

WHEREAS, the QC LGU, through its Local Economic Investment and Promotions Office (LEIPO), has identified the following 166 small businesses as the recipients for the stimulus package to be released in two (2) tranches with the condition, among others, that they shall not retrench any of their employees for a period of three (3) months:
