A RESOLUTION RENEWING THE SPECIAL PERMIT OF NDM BINGO CENTER/HALL TO OPERATE AN ELECTRONIC BINGO OR E-BINGO AT SOGO HOTEL, TRINOMA, NORTH EDSA, BARANGAY PHIL-AM, DISTRICT I, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, to enable the NDM Bingo to continue its legal business operation, there is a need to renew the said Special Permit;




WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant special permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of NDM Bingo Center/Hall to operate an Electronic Bingo or E-Bingo at Sogo Hotel, Trinoma, North EDSA, Barangay Phil-Am, District I, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an Electronic Bingo or E-Bingo granted herein shall be subject to the following conditions:

- a. The holding of Electronic Bingo or E-Bingo shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Electronic Bingo or E-Bingo shall not include the playing of games not related to or other than E-Bingo;
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned bingo center/hall.






