RESOLUTION NO. SP- **8343**, S-2020

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE FOOD ITEMS TO THE PROVINCES OF ALBAY AND CATANDUANES, TO AID IN THE RELIEF EFFORTS TO THE COMMUNITIES SEVERELY AFFECTED BY SUPER TYPHOON ROLLY.

WHEREAS, on November 1, 2020, Super Typhoon Rolly ravaged the Bicol region, particularly the provinces of Catanduanes and Albay, hitting with intense winds, torrential rain, heavy flooding, and strong lahar flow which destroyed thousands of homes and displaced thousands of residents;

WHEREAS, the Department of Agriculture in Bicol reported that P1.1 billion worth of crops were destroyed by the super typhoon, affecting 17,059 hectares with 53,383 metric tons of produce;

WHEREAS, officials of Albay and Catanduanes, the areas in the Bicol region worst hit by typhoon Rolly, appealed for relief goods and other aid as their funds are almost depleted because of the COVID-19 pandemic;

WHEREAS, the Quezon City Government, as an act of solidarity, liberality, and generosity, will donate food items in favor of Albay and Catanduanes Provinces;

WHEREAS, the abovementioned donations will be used to aid in the relief efforts to the communities affected by the onslaught of Super Typhoon Rolly;

WHEREAS, the Provincial Governments of Albay and Catanduanes are more than willing to accept the donation and expressed gratitude and appreciation for the support, kindness, and liberality of the people of Quezon City during times of calamity;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to donate food items to the provinces of Albay and Catanduanes, to aid in the relief efforts to the communities severely affected by Super Typhoon Rolly.






