RESOLUTION NO. SP- **8347**, S-2020

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO GALAXI PETROLEUM FUEL, INC., FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION WITH OFFICE BUILDING (AS BUILT) TO BE LOCATED AT LOT 142 QUIRINO HIGHWAY, BARANGAY BAGBAG, DISTRICT V, QUEZON CITY.

Introduced by Councilor VICTOR V. FERRER, JR.

WHEREAS, Galaxi Petroleum Fuel, Inc., represented by Mr. Nathaniel V. Remitar, with office address at 16th Floor, UDENNA Tower, Rizal Drive corner 4th Avenue, Bonifacio Global City, Taguig City, is applying for a Special Use Permit for the construction and operation of a gasoline refilling station with office building (as built) to be located at Lot 142 Quirino Highway, Barangay Bagbag, District V, Quezon City;

WHEREAS, pursuant to the provisions of the existing Quezon City Zoning Ordinance, gasoline refilling station is among the uses which require the issuance of a Special Use Permit only upon authorization by the Quezon City Council;

WHEREAS, the Sangguniang Barangay of Barangay Bagbag and the neighborhood concerned had interposed no objection to the proposed project;

WHEREAS, the proposed project will provide employment to the barangay residents and will help boost the economic condition of the city;

WHEREAS, the applicant will comply with the necessary requirements as mandated by the said Zoning Ordinance and pertinent rules and regulations.




