RESOLUTION NO. SP- **8361**, S-2020

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO ECOGLOBAL DEVELOPMENT CORPORATION FOR THE CONSTRUCTION OF ADDITIONAL ELEVEN (11)-STOREY AND THREE (3) BASEMENTS TO ONE KATIPUNAN RESIDENCES, A RESIDENTIAL/ COMMERCIAL CONDOMINIUM LOCATED AT NO. 261 KATIPUNAN AVENUE, BARANGAY LOYOLA HEIGHTS, DISTRICT III, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Ecoglobal Development Corporation, represented by Atty. Sugar C. Reyes, is applying for a Certificate of Exception for the construction of additional Eleven (11)-Storey and three (3) basements to One Katipunan Residences, a Residential/Commercial Condominium located at No. 261 Katipunan Avenue, Barangay Loyola Heights, District III, Quezon City.

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the Sangguniang Barangay concerned has interposed no objection to the proposed project;

WHEREAS, the proposed project will not adversely affect the public health, safety, and welfare, and is in keeping with the general pattern of development in the community.



Reyes, for the construction of additional Eleven (11)-Storey and three (3) basements to One Katipunan Residences, a Residential/Commercial Condominium located at No. 261 Katipunan Avenue, Barangay Loyola Heights, District III, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.


