A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO SIGN AND ACCEPT IN BEHALF OF THE QUEZON CITY GOVERNMENT THE DEED OF DONATION AND ACCEPTANCE OF AN AMBULANCE UNIT FROM THE DEPARTMENT OF HEALTH (DOH) PROCURED UNDER THE HEALTH FACILITIES ENHANCEMENT PROGRAM OF THE SAID DEPARTMENT INTENDED FOR THE USAGE OF THE NOVALICHES DISTRICT HOSPITAL.

WHEREAS, inter-institutional facility referral system, disaster preparedness, various contingencies and basic requirements for hospitals dictate on the account of necessity to continuously strengthen institutional capability for rendering critical and emergency care services wherein ambulance service is an integral part thereof;

WHEREAS, the Novaliches District Hospital, hereinafter referred to as NDH, is a local government-owned and mandated institution and a duly accredited Level 1 (30 bed capacity) Hospital with issued Permit to Construct (PTC) for Level 2 (100 bed capacity) by the Department of Health (DOH), specifically located at Quirino Highway, Barangay San Bartolome, District V, Quezon City, has been upgrading its hospital level and bed capacity to accommodate the growing needs of the city;

WHEREAS, corollary to the preceding premise, NDH is in need of additional ambulance service to secure institutional capability for hospital service expansion, and such other contingent instances wherein a fully-equipped medical transport facility is necessary;


WHEREAS, *Barangay Bagbag*, a local government unit located in the 5th District of Quezon City, has received an Ambulance Unit from the Department of Health (DOH) under the Health Facilities Enhancement Program (HFEP). However, the said *Barangay* issued a resolution declining the said donation and manifesting its intention to donate the ambulance unit to NDH instead;

WHEREAS, Section IV.1.c of the DOH Department Order No. 2018-0338 regulating for distribution of medical transport facilities procured under the HFEP supports the adoption of a council resolution that will authorize a health facility under and in behalf of the Local Government Unit to receive the medical transport unit and sign a deed of donation corresponding thereto.

NOW, THEREFORE,




