A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETROMAX GAS STATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE PETROLEUM REFILLING STATION WITH OFFICE BUILDING WHICH SHALL BE LOCATED AT LOT 18, BLOCK 10, BATASAN-SAN MATEO ROAD CORNER SUNNYSIDE DRIVE, BARANGAY BATASAN HILLS, DISTRICT II, QUEZON CITY.

WHEREAS, Petromax Gas Station, a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) for the construction and operation of a Gasoline Refilling Station with office building which shall be located at Lot 18, Block 10, Batasan-San Mateo Road corner Sunnyside Drive, Barangay Batasan Hills, District II, Quezon City;

WHEREAS, under Section 52 (1) of Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016, a Special Use Permit shall be required for the construction and operation of a gasoline refilling station, subject to the authorization by the City Council through a Resolution;

WHEREAS, the members of the Sangguniang Barangay concerned and the residents nearby the place of business did not interpose any objection to the construction and operation of the said business establishment;




