A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH BARANGAY GREATER LAGRO, REPRESENTED BY ITS PUNONG BARANGAY LEO B. GARRA, JR., TO UTILIZE THE TWO HUNDRED FIFTY-FIVE (255) SQUARE METERS GROUND FLOOR AREA OF ITS COMMUNITY CENTER BUILDING LOCATED ALONG MISA DE GALLO STREET, BARANGAY GREATER LAGRO, QUEZON CITY, WHICH SHALL BE USED AS THE "QUEZON CITY DIALYSIS AND LABORATORY CENTER."

WHEREAS, on 8 March 2020 President Rodrigo Roa Duterte issued Proclamation No. 922 "Declaring a State of Public Health Emergency throughout the Philippines" because of the COVID-19 pandemic;

WHEREAS, on 13 March 2020, the Quezon City Council declared Quezon City under a State of Calamity due to the pandemic;

WHEREAS, the high rate of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) spreading represents a challenge to haemodialysis (HD) patients, especially when they have to expose themselves by going to hospitals where probable, suspected and positive Covid-19 individuals are also present;

WHEREAS, Barangay Greater Lagro passed a Resolution requesting the City Mayor, Honorable Ma. Josefina G. Belmonte, to utilize the two hundred fifty-five (255) square meters ground floor area of Barangay Greater Lagro Community Center located along Misa de Gallo Street, Barangay Greater Lagro, which shall be used solely as Quezon City Dialysis and Laboratory Center, and authorizing Punong Barangay Leo B. Garra, Jr. to enter into and sign a Memorandum of Agreement with the Quezon City Government for the said purpose;

WHEREAS, through the Barangay's willingness to turn-over and relinquish its rights in favor of the Quezon City Government the two hundred fifty-five (255) square meters ground floor area of Barangay Greater Lagro Community Center for purposes of establishing the Quezon City Dialysis and Laboratory Center, the Quezon City Government undertakes and the City Mayor is hereby authorized to provide the necessary dialysis equipment, supplies, medicine and personnel for its effective and efficient operation;

WHEREAS, the establishment of the Quezon City Dialysis and Laboratory Center will benefit the residents of Quezon City;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in behalf of all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with Barangay Greater Lagro, represented by its Punong Barangay Leo B. Garra, Jr., to utilize the two hundred fifty-five (255) square meters Ground Floor Area of its Community Center Building located along Misa De Gallo Street, Barangay Greater Lagro, Quezon City, which shall be used as the "Quezon City Dialysis and Laboratory Center."

RESOLVED FURTHER, that a copy of the subject Memorandum of Agreement shall form an integral part of this Resolution.
