*WHEREAS, tricycles are the primary mode of transport in many areas of the City, servicing secondary roads and subdivisions; and their operation greatly affects not only the mobility of the riding populace but also the peace and order; safety and harmony of various areas where these tricycles operate;*

WHEREAS, Section 36 of Republic Act No. 8749, otherwise known as the "Philippine Clean Air Act of 1999", states that local government units (LGUs) shall share the responsibility in the management and maintenance of air quality within their territorial jurisdiction;

WHEREAS, Section 5 (b) of the same Act, defines Air pollution as any alteration of the physical, chemical and biological properties of the atmospheric air, or any discharge thereto of any liquid, gaseous or solid substances that will or is likely to create or to render the air resources of the country harmful, detrimental, or injurious to public health, safety or welfare or which will adversely affect their utilization for domestic, commercial, industrial, agricultural, recreational, or other legitimate purposes;

WHEREAS, Three Wheel Vehicles were already presented to the TODA Presidents across Quezon City. The full product specification and technical features of the unit and placed emphasis on its advantages to the drivers and to the riding public as well, to add it as an alternative to the Tricycle units due for replacement in compliance with City Ordinance No. SP-2763, S-2018 which required Standard Measurement and Technical Specification for EURO IV motor vehicle;

WHEREAS, the Department of Transportation (DOTr) has issued Department Order No. 2017-011, promoting the modernization of existing transport services, brand new and environmental-friendly units and appealing that the same be given priority for the allocation of Certificate of Public Convenience and deployment based on route categories;

WHEREAS, it is in the best interest of the city and the welfare of its constituents to make a cleaner, greener, safer and economical way by patronizing eco-friendly vehicles. The Environmental Management Bureau (EMB) of the Department of Environment and Natural Resources (DENR) must certify that the Three-Wheel Vehicles is EURO 4 Compliant;

WHEREAS, a more holistic program or approach is needed which will not only safeguard the main livelihood of these tricycle drivers and operators, but also provide them with alternative source of income.




