A RESOLUTION URGING THE BUSINESS ESTABLISHMENTS IN QUEZON CITY TO COLLECT PERSONAL DATA TO AID IN CONTACT TRACING RELEVANT TO THE CORONAVIRUS DISEASE (COVID-19) RESPONSE, THE DATA COLLECTION SHALL BE IN ACCORDANCE WITH DATA PRIVACY ACT OF 2012 AND SHALL BE CONSISTENT WITH THE GUIDELINES SET BY THE DEPARTMENT OF HEALTH.

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID) recommended that the National Capital Region be under General Community Quarantine (GCQ) to allow not only the opening of essential businesses, but also, to re-open more non-essential business to gradually revive the Philippine economy amid the COVID-19 crisis for the period of June 01-15, 2020;

WHEREAS, according to the Department of Health (DOH), as of June 02, 2020 we have 18,997 COVID-19 confirmed cases, 4,063 recovered and 966 fatalities;

WHEREAS, despite the increasing number of COVID-19 patients, the Philippine Society for Microbiology and Infectious Disease (PSMID) said that there is no available vaccine to control the pandemic;

WHEREAS, to mitigate the spread of Coronavirus in the community, business establishments within the jurisdiction of Quezon City are encouraged to have a Customer Contact Database, which includes, but not limited to, name/address/contact number/email address/date/time of the transaction;

WHEREAS, this will aid the government agencies with accessible stored personal data to identify, assess, control, and monitor people who have been exposed to the virus, and prevent its transmission;

WHEREAS, data collection shall be in accordance with the Data Privacy Act of 2012 and must be consistent with the Guidelines No. 2020-0189 issued by the Department of Health on Contact Tracing of Close Contacts of Confirmed Coronavirus Disease Cases;

WHEREAS, the success of flattening the curve depends on the cooperation of the public by divulging accurate information that will provide guidance to the authorities in containing the COVID-19 outbreak.



NOW, THEREFORE,




