A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO PURCHASE ONE (1) UNIT OF SERVICE VEHICLE AND ONE (1) UNIT OF MOTORCYCLE AMOUNTING TO ONE MILLION FIVE THOUSAND EIGHT HUNDRED TWENTY-FOUR PESOS (PHP1,005,824.00), TO BE CHARGED AGAINST THE FUNDS OF THE RADIO COMMUNICATIONS SERVICE OFFICE, OFFICE OF THE CITY MAYOR.

1 unit - MOTORCYCLE

Color: Gun Metal Gray; Engine Type Single cylinder, 4-stroke, liquid cooled, SOHC, 4-valves; Displacement 155cc; Bore x stroke 58.0mm x 58.7mm; Compression Ratio 10.5:1; Maximum power 11.1kw @ 8000rpm; Maximum Torque 14.4Nm @ 6000rpm; Lubrication system wet sump; Fuel system Fuel injection; Ignition system TCI; Starter system Electric; Transmission system V-Belt Automatic; Fuel Consumption 2.4l/100km; CO2 emissions 54g/km; Overall length 1955mm; Overall width 740mm; Overall height 1115mm; Seat height 765mm; Wheelbase 1350mm; Minimum ground clearance 135mm; Net weight 127kg; Fuel tank capacity 6.6 liters.
