A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO JNY GLOBAL RESOURCES INC., FOR THE CONSTRUCTION OF A ONE (1)-STOREY CARRYBOY REPAIR SHOP/SHOWROOM (AS BUILT) TO BE LOCATED AT LOT 1, PCS-00-009145, 25 AND 26, BLOCK 6, FAUSTINO STREET, ISIDORA HILLS, BARANGAY HOLY SPIRIT, DISTRICT II, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO.
