WHEREAS, Community Wi-Fi Advocates Consortium (the "Operator") is composed of various telecommunication service providers which intends to provide fixed Wireless Internet (Wi-Fi) Service within Quezon City;

WHEREAS, the Operator shall provide one thousand (1,000) wireless internet equipment at pre-determined Wi-Fi hotspots locations, including the installation and commissioning of the necessary hardware, software, connections, auxiliary equipment and components, and cable distribution system to provide Wi-Fi coverage at no cost to the City;


WHEREAS, the Operator shall provide a complimentary fifty (50) megabytes (MB) allocation per subscriber per day for the complimentary Wi-Fi use, and shall offer to subscribers of the service paid Wi-Fi service with the following features: full coverage on areas where there are customers, co-branded portal page, and daily free MB per subscriber per day;

WHEREAS, the Quezon City Government adopts the policy of the State which recognizes the vital role of information and communications technology in nation building, and the importance of promoting an environment for the development of structures that would ensure the availability and accessibility to reliable and secure internet access suitable to the needs and aspirations of the City;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Community Wi-Fi Advocates Consortium for the provision and installation of equipment and facilities for fixed Wireless Internet (Wi-Fi) Service within Quezon City.
