WHEREAS, the late Punong Barangay Gualberto "Unyo" B. Casaje, Jr. was a local born "Batang Frisco", who dedicated his entire life to public service having served his beloved Barangay Damayan as a duly elected Barangay Kagawad from the year 1994 to 1997, and subsequently as its Punong Barangay for three (3) consecutive terms from 1997 to 2010, and again from 2013 until the time of his demise, where the barangay received numerous awards and recognitions for his accomplishments, projects, and programs that benefitted his community;

WHEREAS, the late Punong Barangay Gualberto "Unyo" B. Casaje, Jr.'s, long service as Barangay Local Chief Executive was marked with commendations and achievements that brought pride and citation to Barangay Damayan, bringing pride to its officials and the entire community leading to his continuous mandate worthy of emulation;

WHEREAS, his untimely demise left his constituencies longing for his selfless brand of "public service above all" not only in Barangay Damayan but also in the entire City as well;
