WHEREAS, President Rodrigo Roa Duterte has appointed Police Lieutenant General Guillermo Lorenzo T. Eleazar (PLTGEN Eleazar) as the new Chief of the Philippine National Police (PNP);

WHEREAS, PLTGEN Eleazar is the 26th chief of the PNP and replaced Police General Debold M. Sinas who reached the mandatory retirement age of 56 years old on 08 May 2021;

WHEREAS, PLTGEN Eleazar belongs to the Philippine Military Academy "Hinirang Class of 1987". He gained popularity for imposing strict discipline on policemen, punishing erring policemen, and rewarding policemen who made the PNP proud.

WHEREAS, prior to PLTGEN Eleazar's appointment, he held the second highest post in the PNP as Deputy Chief for Administration. He also served as Director of the National Capital Region Police Office (NCRPO), the Quezon City Police District (QCPD), and the Police Regional Office 4-A (Calabarzon). PLTGEN Eleazar likewise served as deputy chief for operations and commander of the Joint Task Force Coronavirus (COVID-19) Shield, which implements quarantine rules and protocols;

WHEREAS, through a National Police Commission (NAPOLCOM) Resolution, Department of the Interior and Local Government Secretary Eduardo Año recommended to President Rodrigo Roa Duterte the appointment of PLTGEN Eleazar as PNP chief based on seniority, merit service reputation, and competence to lead the police force;

WHEREAS, in announcing PLTGEN Eleazar's appointment, the Office of the President highlighted his track record of professionalism, dedication and integrity, and confidence that he will continue the reform initiatives of his predecessors and lead the police organization to a greater heights;

WHEREAS, PLTGEN Eleazar stated that he is ready to meet the challenges of leading the more than 220,000 members of strong PNP and expressed his gratitude for being given the opportunity to serve his fellow Filipinos;

WHEREAS, a demonstration of support from the Quezon City Government is appropriate in the assumption of duties by PLTGEN Eleazar as the new chief of PNP.



NOW, THEREFORE,


