RESOLUTION NO. SP- **8553**, S-2021

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH GRACIA TELECOMMUNICATIONS CORPORATION FOR THE PLACEMENT OF PAYMENT KIOSKS FOR BILLS, UTILITIES, AND OTHER PAYMENT SERVICES, INCLUDING THE COLLECTION, TRANSMITTAL, AND REMITTANCE OF THE CITY'S LOCAL TAXES, MISCELLANEOUS FEES, AND CHARGES.

WHEREAS, it is the policy of the Quezon City Government to extend partnership and cooperation with various private entities to facilitate and promote convenient payment transactions for the benefit of its constituents;

WHEREAS, Republic Act No. 8792, otherwise known as the "E-Commerce Act of 2000", recognizes the validity of electronic transactions for purposes of the delivery of government services;

WHEREAS, Republic Act No. 11032, otherwise known as the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018", mandates all offices and agencies to improve their transaction systems, including no-contact and remote procedures;

WHEREAS, Gracia Telecommunications Corporation, a corporation duly organized and existing under and by virtue of Philippine laws, intends to partner with the Quezon City Government to offer a new service where one can pay bills, utilities, credit card loans, load GCash, Smart Padala payments, e-loads as well as local taxes, fees, and other miscellaneous fees and charges for government services using Bills Payment Kiosks;



NOW, THEREFORE,



Belmonte, to enter into a Memorandum of Agreement with Gracia Telecommunications Corporation for the placement of payment kiosks for bills, utilities, and other payment services, including the collection, transmittal, and remittance of the city's local taxes, miscellaneous fees, and charges.
