RESOLUTION NO. SP- **8557**, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO ORTIGAS AND COMPANY LIMITED PARTNERSHIP FOR THE CONSTRUCTION AND OPERATION OF CIRCULO VERDE PHASE 2, TOWER 1 LOCATED AT LOT 1-B CIRCULO VERDE, CALLE INDUSTRIA, BARANGAY BAGUMBAYAN, DISTRICT III, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Ortigas and Company Limited Partnership is applying for the issuance of a Certificate of Exception for the construction and operation of Circulo Verde Phase 2, Tower 1 located at Lot 1-B Circulo Verde, Calle Industria, Barangay Bagumbayan, District III, Quezon City in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the said application is for the purpose of complying with the parking requirement provided under the Zoning Ordinance;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;




NOW, THEREFORE,
