A RESOLUTION GRANTING A SPECIAL PERMIT TO GENX SPORTS AND MEDIA PRODUCTION CORPORATION, REPRESENTED BY MR. JOSEPH ELPHIN LUMBAD, WITH BUSINESS ADDRESS AT THE 16<sup>TH</sup>, 20<sup>TH</sup>, 24<sup>TH</sup>-27<sup>TH</sup> FLOORS, CYBER ONE BUILDING, 11 EASTWOOD, QUEZON CITY, TO OPERATE BUSINESS PROCESS OUTSOURCING, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE SECURITIES AND EXCHANGE COMMISSION (SEC) AND BUREAU OF INTERNAL REVENUE (BIR).

WHEREAS, *Genx Sports and Media Production Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Joseph Elphin Lumbad, is applying for a Special Permit to operate a Business Process Outsourcing with business address at the 16<sup>th</sup>, 20<sup>th</sup>, 24<sup>th</sup>-27<sup>th</sup> Floors, Cyber One Building, 11 Eastwood, Quezon City;*

WHEREAS, *to enable the applicant to operate the aforesaid Business Process Outsourcing, there is a need to secure a Special Permit from the City Council pursuant to an existing city ordinance;*

WHEREAS, *Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing ordinances, authorizes the City Council to grant or renew a special permit to business activity of the same nature.*

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Genx Sports and Media Production Corporation, represented by Mr. Joseph Elphin Lumbad, to operate a Business Process Outsourcing with business address at the 16<sup>th</sup>, 20<sup>th</sup>, 24<sup>th</sup>-27<sup>th</sup> Floors, Cyber One Building, 11 Eastwood, Quezon City, subject to the rules and regulations promulgated by the Securities and Exchange Commission (SEC) and Bureau of Internal Revenue (BIR).


