A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO GREAT VALLEY MEDICAL CENTER FOR THE CONSTRUCTION OF A PROPOSED FIFTEEN (15)-STOREY BUILDING WITH SIX (6) BASEMENT-PARKING LEVELS TO BE LOCATED AT NO. 34 PANAY AVENUE CORNER ROCES AVENUE, BARANGAY PALIGSAHAN, DISTRICT IV, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, *Great Valley Medical Center is applying for a Certificate of Exception for the construction of a proposed fifteen (15)-Storey Building with six (6) Basement-Parking Level located at No. 34 Panay Avenue corner Roces Avenue, Barangay Paligsahan, District IV, Quezon City in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;*

WHEREAS, *pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;*

WHEREAS, *the purpose of the said application is to comply with the Zone Classification from commercial to institutional, as well as to the Floor Area Ratio (FAR) requirement of the zoning ordinance;*

WHEREAS, *the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;*
