RESOLUTION NO. SP- **8566** , S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO DRA. LETICIA M. YAO FOR THE CONSTRUCTION OF A PROPOSED SEVEN (7)-STOREY HOSPITAL TO BE LOCATED AT LOT 2, BLOCK 153, (NO. 3) N. RAMIREZ STREET CORNER STO. TOMAS STREET, BARANGAY DON MANUEL, DISTRICT IV, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Dra. Leticia M. Yao is applying for the issuance of a Certificate of Exception for the construction of a proposed Seven (7)-Storey Hospital Building to be located at Lot 2, Block 153, (No. 3) N. Ramirez Street corner Sto. Tomas Street, Barangay Don Manuel, District IV, Quezon City, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the said application is for the purpose of complying with the zone classification of the project location;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;

Tomas Street, Barangay Don Manuel, District IV, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
