RESOLUTION NO. SP-8572, S-2021

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACCEPT THE DONATION FROM MAYNILAD WATER SERVICES, INC. AND EXECUTE THE RELATED DEED OF DONATION AND ACCEPTANCE FOR THE INSTALLATION OF TWO (2) UNITS OF PRE-FABRICATED CONTACTLESS HANDWASH STATIONS WITH STEEL PEDAL PUSH BUTTON FAUCET AND PEDAL OPERATED SOAP DISPENSER, WITH THE OBJECTIVE OF PROMOTING PROPER HYGIENE AND SANITATION PRACTICES IN COMBATING THE HARMFUL EFFECTS OF COVID-19.

Introduced by Councilors FRANZ S. PUMAREN and DONATO "Donny" C. MATIAS.

WHEREAS, on 8 March 2020, President Rodrigo Roa Duterte declared a State of Public Health Emergency in the Philippines through Proclamation No. 922 to facilitate measures to address the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, in a Special Session hold on 13 March 2020, the Quezon City Council adopted Resolution No. SP-8141, Series of 2020 which declared a State of Calamity in Quezon City due to COVID-19;

WHEREAS, Republic Act No. 11469, otherwise known as the Bayanihan to Heal as One Act, declared a state of national emergency over the entire country;

WHEREAS, Maynilad Water Services, Inc., by virtue of the Concession Agreement dated February 21, 1997, as amended, clarified, and extended, is the Metropolitan Waterworks and Sewerage System's agent and contractor in providing water and wastewater services in the West Zone of the Metropolitan Manila Area;

WHEREAS, Maynilad Water Services, Inc., in response to the government's call for a collective action to combat COVID-19, and as part of its corporate social responsibility initiative to continue promoting proper hygiene and sanitation practices, intends to make a donation to the Quezon City Government;

WHEREAS, this donation consists of two (2) units of pre-fabricated contactless handwash stations with steel pedal push-button faucet and pedal operated soap dispenser to be installed at the designated areas to be determined by the parties, including the provision of liquid hand soap at the handwash stations for the first three (3) months of operations, which shall be equivalent to forty-five (45) liters of liquid hand soap per month;

WHEREAS, the generosity of the officers and members of the Maynilad Water Services, Inc. during this time of COVID-19 pandemic is greatly appreciated by the Quezon City Government;

WHEREAS, pursuant to Section 22 (c) and Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to accept the donation from Maynilad Water Services, Inc. and execute the related Deed of Donation and Acceptance for the installation of two (2) units of pre-fabricated contactless handwash stations with steel pedal push-button faucet and pedal operated soap dispenser, with the objective of promoting proper hygiene and sanitation practices in combating the harmful effects of COVID-19.
