RESOLUTION NO. SP- **8575**, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO NEW PHOENIX CONSTRUCTION SUPPLY CORP. FOR THE CONSTRUCTION AND OPERATION OF A THREE (3) UNITS, ONE (1)-STOREY WAREHOUSE BUILDING (AS BUILT) LOCATED AT LOT 13, BLOCK 2, NO. 16, GOLDEN STREET, GLORIA-1 SUBDIVISION, BARANGAY TANDANG SORA, DISTRICT VI, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, New Phoenix Construction Supply Corp. is applying for a Certificate of Exception for the construction and operation of a three (3) units, one (1)-storey warehouse building (as built) located at Lot 13, Block 2, No. 16, Golden Street, Gloria-1 Subdivision, Barangay Tandang Sora, District VI, Quezon City;

WHEREAS, the New Phoenix Construction Supply Corp. is asking for an exception as regards to their location of the proposed project which is classified as Medium Density Residential (R2) Zone, wherein storage facilities/warehouses are not included among the list of permissible uses in a Medium Density Residential Zone (R2), hence, the proposed project is not permissible in the said location thereby necessitating the owner to apply before the City Council for the issuance of a Certificate of Exception to be exempt from zoning restriction;

WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, an exception or deviations from the provisions of Zoning Ordinance may be allowed only upon authorization from the City Council;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;


WHEREAS, the Sangguniang Barangay and the homeowners concerned have interposed no objection to the said project;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to New Phoenix Construction Supply Corp. for the construction and operation of a three (3) units, one (1)-storey warehouse building (as built) located at Lot 13, Block 2, No. 16, Golden Street, Gloria-1 Subdivision, Barangay Tandang Sora, District VI, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.


