A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A SPECIFIC IMPLEMENTATION AGREEMENTS WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT-NATIONAL CAPITAL REGION (DSWD-NCR) FOR THE IMPLEMENTATION OF THE CASH-FOR-WORK PROGRAM AND PANTAWID PAMILYANG PILIPINO PROGRAM IN QUEZON CITY.

*WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that every local government unit shall exercise powers that are essential to the promotion of general welfare within their territorial jurisdiction, which includes implementation of social welfare programs that are geared towards assisting the underprivileged, unemployed, and marginalized within Quezon City;*

*WHEREAS, it is the policy of the Quezon City Government to extend partnership and cooperation with government offices and agencies in addressing social welfare issues which affect its constituents;*

WHEREAS, the Department of Social Welfare and Development (DSWD) is mandated by law to develop, administer, and implement comprehensive social welfare programs designed to uplift the living conditions and empower the disadvantaged children, youth, women, older persons, person with disabilities, families in crisis or at-risk and communities needing assistance;

WHEREAS, while the delivery of most basic services was devolved to the local government units, the DSWD is mandated to do policy and program development, standard setting, technical assistance, and monitoring functions to local government units to effectively implement social welfare and development programs in target areas;

WHEREAS, the DSWD has proposed to enter into a Specific Implementation Agreements with the Quezon City Government relative to the implementation of various social welfare programs and projects within the City, including but not limited to the Pantawid Pamilyang Pilipino Program (4Ps) and Cash For Work Program, among others;

WHEREAS, the implementation of the Pantawid Pamilyang Pilipino Program adheres to the provisions stipulated in the RA 11310: An Act Institutionalizing the Pantawid Pamilyang Pilipino Program (4Ps) and elaborated in its Implementing Rules and Regulationsto improve the level of well-being of its poor constituents and mandated the DSWD to coordinate with different national government and local government agencies, including organizations from the private sector to ensure full implementation;

WHEREAS, the Cash for Work Program will be utilized through the Urban Farming Project with a target beneficiaries of two thousand (2000) poor households that will be funded by the DSWD with the objective of empowering the selected responsive citizens, imbibing the concept of self-reliance and resiliency, participating in the implementation of community projects and providing oppoutunities for alternative source of income that will help the beneficiaries meet their daily needs and eventually become a permanent source of income;

WHEREAS, the Quezon City Government, through the Social Services Development Department (SSDD) with technical assistance from the DSWD-NCR, will carry on the implementation of programs identified in the Specific Implementation Agreements, for the Cash-for-Work Program, while the Local Advisory Council shall ensure the convergence of services and oversee the proper implementation of social welfare programs at the local level of the Pantawid Pamilyang Pilipino Program;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Specific Implementation Agreements with the Department of Social Welfare and Development-National Capital Region (DSWD-NCR) for the implementation of the Cash-for-Work Program and Pantawid Pamilyang Pilipino Program in Quezon City.


RESOLVED FURTHER, that copies of the subject agreements shall form an integral part of this Resolution.
