WHEREAS, the rapid spread of the COVID-19 pandemic in the heavily congested National Capital Region brought to fore long-standing issues on the lack of viable and sustainable employment opportunities in the countryside, unbalanced regional development, and unequal distribution of wealth;

WHEREAS, on May 6, 2020, President Rodrigo Roa Duterte issued Executive Order No. 114, Institutionalizing the Balik Probinsya, Bagong Pag-asa Program as a pillar of balanced Regional Development, Creating a Council therefor, and for other purposes;

WHEREAS, this program is geared towards addressing Metro Manila's congested urban areas by encouraging people, especially informal settlers to return to their home provinces and assist them in this transition with support and incentives on transportation, family, livelihood, housing, subsistence and education, among others;

WHEREAS, eighty-five families - a total of 112 persons - became the first batch of beneficiaries of the Balik Probinsya, Bagong Pag-asa (BP2) Program, and were sent off by City Mayor Joy Belmonte, and other officials, as they left Cubao, Quezon City for Palo, Leyte last May 20, 2020;

WHEREAS, the Balik Probinsya, Bagong Pag-asa (BP2) Program opens up the possibility of a better future for Filipinos through equity in resources throughout the country that will boost countryside development.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to strongly support, as it does hereby strongly support, the Balik Probinsya, Bagong Pag-asa Program of the National Government, as institutionalized under Executive Order No. 114 of President Rodrigo Roa Duterte.
