RESOLUTION NO. SP- **8600**, S-2021

A RESOLUTION GRANTING A SPECIAL USE PERMIT TO MANILA MEMORIAL PARK CEMETERY, INC. FOR THE OPERATION OF AN EXTENSION OF MEMORIAL PARK (HOLY CROSS PHASE-II) LOCATED AT LOT 199-B-1-B-1, BARANGAY SAN BARTOLOME, DISTRICT V, QUEZON CITY.

WHEREAS, Section 458 (a)(4)(ix), Article III, Chapter III, Title III of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, vests in the Sangguniang Panlungsod the power to “regulate the establishment, operation and maintenance of funeral parlors and the burial or cremation of the dead, subject to existing laws, rules and regulations”;

WHEREAS, the Manila Memorial Park Cemetery, Inc. is applying for a Special Use Permit for the operation of an Extension of Memorial Park (Holy Cross Phase-II) located at Lot 199-B-1-B-1, Barangay San Bartolome, District V, Quezon City;

WHEREAS, the said applicant is technically and financially capable to operate and maintain a Memorial Park/Lots and in fact has complied with the requirements provided under Ordinance No. SP-2502, S-2016;

WHEREAS, the operation of the said business will help boost the economic growth of the city and can create jobs for its constituents.

NOW, THEREFORE,




