A RESOLUTION ADOPTING THE 2021 ANNUAL INVESTMENT PLAN (AIP) OF THE QUEZON CITY GOVERNMENT (QCG) FOR SUPPLEMENTAL BUDGET NO. 1 IN THE AMOUNT OF SIX BILLION ONE HUNDRED THIRTY-ONE MILLION THREE HUNDRED THIRTY-THREE THOUSAND FIVE HUNDRED TWENTY-FIVE PESOS (PHP6,131,333,525.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.
