WHEREAS, Dr. Domingo Goan Landicho, a Professor Emeritus of the University of the Philippines (UP) and Writer-in-Residence of the De La Salle University (DLSU), is a well-known novelist, poet, playwright, biographer, and author of more than 50 books, a theater, television, and film actor, and a painter of note;

WHEREAS, as a writer and professor, Dr. Landicho brought the Philippine language and literature for world consciousness in 1995, in his capacity as Examiner Responsible for Filipino Language of the International Baccalaureate Organization, based in Wales, United Kingdom. Servicing international schools all over the world where the Philippine National Language is taught to young advanced middle level school students;

WHEREAS, as a world renown literary figure who acted as President of the 16<sup>th</sup> World Congress of Poets in August 2000, Dr. Landicho was instrumental in putting Philippine letter in the world limelight by bringing into the country poets from all over the world and that as a recognition of his achievement and leadership. He was chosen by the International Biographical Centre Cambridge in England as "One of the 20<sup>th</sup> Century's Outstanding Writers";

WHEREAS, Dr. Landicho is a pride of Quezon City who deserves the recognition from the city being his hometown, for his outstanding accomplishments in the field of literature that brought great honor and glory to our community and to our country.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the National Commission for Culture and the Arts (NCCA) to confer upon Dr. Domingo Goan Landicho, PhD., one of the most illustrious residents of Barangay Greater Lagro, Novaliches, Quezon City, as recipient of the "Order of the National Artist for Literature" of the Philippines in recognition of his significant achievements and artistic contributions in the field of literature.




