RESOLUTION NO. SP- **8605**, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MR. GEORGE D. PERALTA FOR THE CONSTRUCTION AND OPERATION OF A ONE (1)-STOREY WAREHOUSE BUILDING WITH MEZZANINE TO BE LOCATED AT LOT 18, BLOCK 2, NO. 8 PURAY STREET, BARANGAY SANTOL, DISTRICT IV, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Mr. George D. Peralta is applying for the issuance of a Certificate of Exception for the construction and operation of a one (1)-storey warehouse building with mezzanine to be located at Lot 18, Block 2, No. 8 Puray Street, Barangay Santol, District IV, Quezon City;

WHEREAS, the location of the proposed project is classified as High Density Residential Zone (R3), hence, the proposed project is not permissible in the said location which necessitates the owner to apply before the City Council an authority for the issuance of a Certificate of Exception to be exempt from zoning restriction;

WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, an exception or deviations from the provisions of Zoning Ordinance may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the Sangguniang Barangay and the homeowners concerned have interposed no objection to the said project;

WHEREAS, the applicant has complied with all the necessary requirements prescribed by law, ordinance and administrative issuances.


NOW, THEREFORE,
