RESOLUTION NO. SP-8606, S-2021

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH VICTORY LINER, INC. FOR THE DONATION TO AND ACCEPTANCE BY THE QUEZON CITY GOVERNMENT OF ONE THOUSAND (1,000) DOSES OF ASTRAZENECA COVID-19 VACCINES WITH A REQUEST FOR ASSISTANCE FOR THE VACCINATION OF ITS EMPLOYEES WORKING IN QUEZON CITY.

WHEREAS, it is the policy of the local government of Quezon City (QC LGU) to extend partnership and cooperation with various organizations and private entities in addressing health issues which affect its constituents;

WHEREAS, the QC LGU is committed to collaborate with various stakeholders in their efforts to prevent, mitigate, and contain the spread of COVID-19 within its territorial jurisdiction;

WHEREAS, Victory Liner, Inc. ("Victory Liner") intends to enter into a Memorandum of Agreement (MOA) with the QC LGU for the former's donation of one thousand (1,000) doses of AstraZeneca COVID-19 vaccines to QC LGU as part of its Corporate Social Responsibility Program;

WHEREAS, Victory Liner, Inc. has likewise requested the assistance of QC LGU for the vaccination of its employees working in and around the vicinity of Quezon City;

WHEREAS, in consideration of the donation made by Victory Liner in favor of QC LGU, the latter commits to use its own personnel, free of charge, for the vaccination of seven hundred fifteen (715) Victory Liner employees to be conducted at Jaycees Vaccine Storage Warehouse at EDSA Road, Kamuning, Quezon City (beside QCPD Police Station 10 - Kamuning);

WHEREAS, the QC LGU will accept the delivery of vaccines and store the same at the QC LGU's cold storage facility located at the aforesaid Jaycees Vaccine Storage Warehouse for the use of the Victory Liner's employees;

WHEREAS, Victory Liner will provide for the additional medical supplies needed for the vaccination of its own employees, such as, but not limited to, syringes, cotton balls, band-aids and alcohol;

WHEREAS, Victory Liner will also provide for the meals of the QC LGU personnel who will perform the vaccination on the date and at the place scheduled for said activity;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with Victory Liner, Inc. for the donation to and acceptance by the Quezon City Government of One Thousand (1,000) doses of AstraZeneca COVID-19 vaccines with a request for assistance for the vaccination of its employees working in Quezon City.
