RESOLUTION NO. SP- **8612**, S-2021

A RESOLUTION GRANTING THE ISSUANCE OF A SPECIAL PERMIT TO GLORIOUS THRONE DATA COMPANY INC., FOR THE OPERATION OF ELECTRONIC GAMING STUDIO FOR E-BINGO, ELECTRONIC GAMING, DATA STREAMING TO BE LOCATED AT 30/F CYBERONE BUILDING, NO. 11 EASTWOOD AVENUE, EASTWOOD CITY CYBERPARK, BARANGAY BAGUMBAYAN, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS OF THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, petitioner Glorious Throne Data Company Inc., a content provider and data streaming business entity registered by the Securities and Exchange Commission with Company Registration No. CS201715414 located at Unit 808 Raffles Corporate Building, Emerald Avenue, Barangay San Antonio, Pasig City, is applying for a Special Permit to operate a Gaming Studio for E-Bingo, Electronic Gaming and Data Streaming at 30/F Cyberone Building No. 11 Eastwood Avenue, Eastwood City Cyberpark, Barangay Bagumbayan, District III, Quezon City;

WHEREAS, operating an electronic games is among the businesses that require a Special Permit to be granted by the Quezon City Council in accordance with the provisions of Ordinance No. SP-2285, S-2014;

WHEREAS, Glorious Throne Data Company Inc. has complied with all the necessary requirements for the issuance of a Special Permit as mandated by the aforementioned ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the issuance of a Special Permit to Glorious Throne Data Company Inc., for the operation of Electronic Gaming Studio for E-Bingo, Electronic Gaming, Data Streaming to be located at 30/F Cyberone Building, No. 11 Eastwood Avenue, Eastwood City Cyberpark, Barangay Bagumbayan, District III, Quezon City.

RESOLVED FURTHER, that the PAGCOR's licensed Glorious Throne Data Company Inc. shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the annual gross administrative and operations commissions, payable annually to the City Treasury during the lifetime of this measure.

RESOLVED FINALLY, that the authority herein granted shall be for a period of two (2) years and may be renewed by the Quezon City Council.
