RIZAL STREET CORNER DIEGO SILANG STREET, BARANGAY STA. LUCIA, NOVALICHES, DISTRICT V, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, JNP Space Rental is applying for the issuance of a Certificate of Exception for the construction and operation of a two (2)-storey residential building (As Built) located at No. 107 J.P. Rizal Street corner Diego Silang Street, Barangay Sta. Lucia, Novaliches, District V, Quezon City in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the application for the issuance of a Certificate of Exception is for the purpose of complying with the parking requirement and zone classification of the project location;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;

WHEREAS, the applicant has submitted the necessary and mandatory requirements in support of the proposed project and undertakes to comply with the provisions of existing laws, ordinances, and rules and regulations pertaining to public safety, environmental protection, and vehicular traffic.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to JNP Space Rental for the construction and operation of a two (2)-storey residential building (As Built) located at No. 107 J.P. Rizal Street corner Diego Silang Street, Barangay Sta. Lucia, Novaliches, District V, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
