SOTTO, AND THE HONORABLE MEMBERS OF THE 21<sup>ST</sup> CITY COUNCIL TO THE BEREAVED FAMILIES OF THE MEN AND WOMEN IN UNIFORM ABOARD PHILIPPINE AIR FORCE (PAF) C-130 HERCULES PLANE THAT FATALLY CRASHED IN PATIKUL, SULU.

*WHEREAS, the C-130 military plane was transporting troops from Cagayan De Oro, in Mindanao, to Sulu province when apparently missed the runway on the island of Jolo;*

*WHEREAS, the plane, which was carrying 96 military personnel and crew, crashed into nearby Patikul village at 11:30 a.m. local time on Sunday;*

*WHEREAS, Major General Edgard Arevalo, a spokesman for the military, said 47 army personnel died, while 49 survived the crash and are being treated in hospitals;*


