WHEREAS, cremation, which is the process of reducing a dead body to flame and intense heat followed by pulverization of bone fragments, has gain acceptance in lieu of the traditional burial for reason that it is less expensive and was recently imposed by the government to the departed who succumb to the harmful effect of COVID-19;

WHEREAS, columbarium is a building or room with special spaces for the holding or storage of funerary urns containing the ashes of deceased people;


