RESOLUTION NO. SP-8646, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO CALTEX PHILIPPINES FOR THE PROPOSED CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION WITH COMMERCIAL SPACE TO BE LOCATED AT LOT 1-D-1, KATIPUNAN AVENUE EXTENSION CORNER WHITE PLAINS AVENUE, BARANGAY WHITE PLAINS, DISTRICT III, QUEZON CITY.

Introduced by Councilor IVY L. LAGMAN.

WHEREAS, Caltex Philippines is applying for the issuance of a Special Use Permit for the proposed construction and operation of a Gasoline Service Station with Commercial Space to be located at Lot 1-D-1, Katipunan Avenue Extension corner White Plains Avenue, Barangay White Plains, District III, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception maybe issued for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect public health, safety, and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located;

WHEREAS, the applicant has complied with all the documentary and mandatory requirements as provided under existing and applicable laws, rules, ordinances and issuances.
