RESOLUTION NO. SP- **8647**, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO STARMARS TRADING CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE STATION WITH OFFICE BUILDING (AS BUILT) TO BE LOCATED AT LOTS 6, 8 AND 10, BLOCK 43, REGALADO AVENUE, BARANGAY NORTH FAIRVIEW, DISTRICT V, QUEZON CITY.

WHEREAS, Starmars Trading Corporation is applying for a Special Use Permit for the construction and operation of a gasoline station with office building (As Built) to be located at Lots 6, 8 and 10, Block 43, Regalado Avenue, Barangay North Fairview, District V, Quezon City;

WHEREAS, pursuant to the provisions of the existing Quezon City Zoning Ordinance, gasoline refilling station is among the uses which require the issuance of a Special Use Permit and the same maybe issued only upon authorization by the Quezon City Council;

WHEREAS, the Sangguniang Barangay and the neighborhood concerned had interposed no objection to the proposed project;

WHEREAS, the proposed project will provide employment to the barangay residents and will help boost the economic condition of the city;

WHEREAS, the applicant will comply with the necessary requirements as mandated by the said Zoning Ordinance and pertinent rules and regulations.


