WHEREAS, the Quezon City Government, through the City Council, consistently complies with the mandate of the Local Government Code of 1991 and conducts accreditation and election of sectoral representatives, hence, the creation of Quezon City Council of Sectoral Representatives (QC-CSR), the members of which become automatic members of the City Development Council;

WHEREAS, the QC-CSR has always involved itself and take part in the formulation of policies and programs of the city and independently conducts and initiates its own programs for the benefit of all accredited organizations, associations, NGO's and PO's in Quezon City;

WHEREAS, there are presently fifty (50) members of the QC-CSR, like in the past several years, and each member has a duty to coordinate the City's policies to its member-sectors, consolidate recommendations from accredited organizations for policy-making and serves as one of the links of the Quezon City Government to all the sectors;

WHEREAS, the members of the QC-CSR perform their duties to contribute to the success of the City's plans for its residents and do such without any compensation from the city, most members of whom belong to the marginalized sectors;

WHEREAS, medical and burial assistance is both timely, and in due recognition of the contribution of the QC-CSR members to Quezon City, especially during this trying times of COVID-19 pandemic.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request, the City Government to provide medical and burial assistance to the incumbent members of the Council of Sectoral Representatives (CSR).
