RESOLUTION NO. SP- **8655**, S-2021

A RESOLUTION RENEWING THE SPECIAL PERMIT OF AB LEISURE EXPONENT, INCORPORATED TO OPERATE AN ELECTRONIC BINGO (E-BINGO) AND TRADITIONAL BINGO AT SM CITY NORTH ANNEX BUILDING, EDSA, BARANGAY BAGONG PAG-ASA, DISTRICT I, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, AB Leisure Exponent, Incorporated is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at SM City North Annex Building, EDSA, Barangay Bagong Pag-Asa, District I, Quezon City;

WHEREAS, AB Leisure Exponent, Incorporated is primarily engaged in the business of Electronic Bingo (E-Bingo) and Traditional Bingo;

WHEREAS, to enable the applicant to operate an Electronic Bingo and Traditional Bingo in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to existing ordinance in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, AB Leisure Exponent, Incorporated is requesting the City Council to renew the Special Permit to operate an Electronic and Traditional Bingo Boutique.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of AB Leisure Exponent, Incorporated to operate an electronic Bingo (E-Bingo) and Traditional Bingo at SM City North Annex Building, EDSA, Barangay Bagong Pag-Asa, District I, Quezon City, subject to the rules and regulations promulgated by Philippine Amusement and Gaming Corporation (PAGCOR).
