RESOLUTION NO. SP-**8663**, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO LAKPUE DRUG, INC. FOR THE CONSTRUCTION AND OPERATION OF A SEVEN (7)-STOREY RESIDENTIAL/COMMERCIAL BUILDING WITH BASEMENT PARKING (AS BUILT) LOCATED AT LOT 23, BLOCK 4, NO. 24 LDI BUILDING, 12TH AVENUE, BARANGAY SOCORRO, DISTRICT III, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, *Lakpue Drug Inc., owned by Mr. Enrique Y. Castillo, Jr., is applying for the issuance of a Certificate of Exception for the construction and operation of a Seven (7)-Storey Residential/Commercial Building with Basement Parking (as built) located at Lot 23, Block 4, No. 24 LDI Building, 12th Avenue, Barangay Socorro, District III, Quezon City in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;*

WHEREAS, *pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;*

WHEREAS, *compliance with the zone classification is being requested for the said exception;*

WHEREAS, *the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;*

WHEREAS, *the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;*

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Lakpue Drug, Inc. for the construction and operation of a Seven (7)-Storey Residential/Commercial Building with Basement Parking (as built) located at Lot 23, Block 4, No. 24 LDI Building, 12th Avenue, Barangay Socorro, District III, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
