RESOLUTION NO. SP- **8664**, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO SPOUSES MARIANO N. NOGA AND ELSIE P. NOGA FOR THE CONSTRUCTION OF A TWO (2)-STOREY INDUSTRIAL WAREHOUSE (AS BUILT) LOCATED AT LOT 5, BLOCK 8, DON ELPIDIO STREET, DON ANTONIO HEIGHTS, BARANGAY HOLY SPIRIT, DISTRICT II, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Spouses Mariano N. Noga and Elsie P. Noga, project owners, are applying for the issuance of a Certificate of Exception for the construction of a two (2)-storey industrial warehouse (as built) located at Lot 5, Block 8, Don Elpidio Street, Don Antonio Heights, Barangay Holy Spirit, District II, Quezon City in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the exception being requested is for the purpose of complying with the parking requirement and zone classification of the project location;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;

Noga for the construction of a two (2)-storey industrial warehouse (as built) located at Lot 5, Block 8, Don Elpidio Street, Don Antonio Heights, Barangay Holy Spirit, District II, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
