A RESOLUTION ADOPTING THE QUEZON CITY GENDER AND DEVELOPMENT (GAD) PLAN AND BUDGET FOR THE FISCAL YEAR 2022 IN THE AMOUNT OF TWO BILLION THREE HUNDRED SIXTY-EIGHT MILLION SIX HUNDRED FIFTY-FOUR THOUSAND SIX HUNDRED FIVE PESOS AND TWENTY-ONE CENTAVOS (PHP2,368,654,605.21).

WHEREAS, Ordinance No. SP-2501, S-2016 established the Quezon City Gender and Development Code;

WHEREAS, the abovementioned ordinance provides for the creation of the GAD Technical Working Group (TWG). One of the functions of the GAD TWG is to extensively review the GAD Plan and Budget of all the departments and offices of the Quezon City Local Government, pursuant to the guidelines set forth under Joint Memorandum Circular No. 2013-01 providing for the preparation of Annual GAD Plan and Budget and Accomplishment Report to Implement the Magna Carta of Women;

WHEREAS, after substantial review of the GAD Plan and Budget of all the departments and offices, the TWG submitted to the GAD Council the consolidated GAD Plan and Budget of Quezon City for the year 2022 in the amount of Two Billion Three Hundred Sixty-Eight Million Six Hundred Fifty-Four Thousand Six Hundred Five Pesos and Twenty-One Centavos (Php2,368,654,605.21);

WHEREAS, the GAD planning and budgeting shall be conducted annually as part of the programming and budgeting exercise of all the departments and offices, and shall be reflected in the Annual Work and Financial Plan (WFP) of the city;

WHEREAS, the Gender and Development Council approved the City's GAD Plan and Budget for the Fiscal Year 2022 for submission to the Department of the Interior and Local Government (DILG).
