A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO SOUTHEAST ASIA RETAIL, INC. (CALTEX GASOLINE STATION) FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE STATION WITH OFFICE BUILDING TO BE LOCATED AT NO. 1240 EDSA, BALINTAWAK, BARANGAY APOLONIO SAMSON, DISTRICT VI, QUEZON CITY.
