A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACCEPT THE DONATION FROM GOLDEN ABC, INCORPORATED FOR THE DONATION OF TWO HUNDRED FIFTY (250) VIALS (2,500 DOSES) OF ASTRAZENECA COVID-19 VACCINES FOR THE INOCULATION OF RESIDENTS AND WORKERS IN QUEZON CITY.

WHEREAS, Golden ABC, Incorporated has expressed its desire to assist the Quezon City Government's COVID-19 response by donating its company procured COVID-19 vaccines pursuant to the tripartite agreement with AstraZeneca Pharmaceuticals Philippines Inc., National Government (Task Force Against COVID-19) and Go Negosyo, to wit:

Belmonte, to accept the donation from Golden ABC, Incorporated for the donation of two hundred fifty (250) vials (2,500 doses) of AstraZeneca COVID-19 vaccines for the inoculation of residents and workers in Quezon City.
