A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACCEPT THE DONATION FROM GOLDEN ABC, INCORPORATED FOR THE DONATION OF TWO HUNDRED FIFTY (250) VIALS (2,500 DOSES) OF ASTRAZENECA COVID-19 VACCINES FOR THE INOCULATION OF RESIDENTS AND WORKERS IN QUEZON CITY.
