A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH RS CONCEPTS, INC., REPRESENTED BY ITS MANAGING DIRECTOR, HORACIO O. ALFONSO, FOR THE LEASE OF CITY OWNED LAMP POSTS FOR ADVERTISEMENTS.

*WHEREAS, on 20 September 2021, the Quezon City Council approved Ordinance No. SP 3044, S-2021, entitled: "An Ordinance Regulating Billboards, Signs and Other Outdoor Media in Quezon City Government Property, Providing for the Procedure for Applying for Installation of Such Outdoor Media, and Other Connected Purposes";*

WHEREAS, Section 4 of Ordinance No. SP-3044, S-2021, designated the Quezon City Property Billboards Regulatory Committee ("Committee") to review the applications of outdoor media service providers and recommend the same for the approval of the City Mayor and the City Council;

WHEREAS, Quezon City owns the lamp posts within the city, which can serve as tools to generate additional revenue to the city as advertising media by way of display of advertising paraphernalia;

WHEREAS, on 08 October 2021, RS Concepts, Inc. submitted a letter of intent to the Office of the City Administrator to undertake the task of marketing of the advertising spaces of lamp posts within the city to prospective clients/advertisers;

WHEREAS, the City Administrator referred the application of RS Concepts, Inc. to the appropriate Committee for Evaluation;

WHEREAS, on 11 October 2021, the Committee convened to evaluate the application of RS Concepts, Inc. and agreed to recommend the same to the City Council;

WHEREAS, on 11 October 2021, the Committee signed a Resolution No. 02, Series of 2021, entitled: "Resolution Recommending to the City Council the Passage of a Resolution to Authorize the City Mayor to Enter into a Memorandum of Agreement with RS Concepts, Inc. for the Lease of Lamp Posts for Advertisements."

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with RS Concepts, Inc., represented by its Managing Director, Horacio O. Alfonso, for the lease of city owned lamp posts for advertisements.


