WHEREAS, K & I Petron Service Center is applying for a Special Use Permit for the construction and operation of a Petron Gasoline Refilling Station and Lube Service Center (As Built) located at No. 77 Kanlaon Street corner Nicanor Roxas Street, Barangay Lourdes, District I, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, a Special Use Permit is required prior to the operation of a gasoline station;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect the public health, safety and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located;

WHEREAS, the applicant has complied with all the documentary and mandatory requirements as provided under existing and applicable laws, rules, ordinances and issuances.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to K & I Petron Service Center for the construction and operation of a Petron Gasoline Refilling Station and Lube Service Center (as built) located at No. 77 Kanlaon Street corner Nicanor Roxas Street, Barangay Lourdes, District I, Quezon City.
